By entering this Sweepstakes, each Entrant warrants that they meet the above eligibility requirements and agrees to these Official Rules.

To Enter: The promotion entry period begins June 5th, 2017, at 12:00:00 a.m. Eastern Standard Time ("EST") and ends on July 15th, 2017, at 11:59:59 p.m. EST ("Promotion Period"). During the Promotion Period, Entrants are encouraged but not required to schedule to have an old refrigerator or freezer recycled by visiting ARCA Inc.'s web site at www.RetireYourFridge.com ("Website") or by calling toll-free at 877-889-4761 ("Hotline"). Entrants who both contact ARCA and have their old unit picked up for recycling within the Promotion Period will be automatically entered into the Sweepstakes. 10 Entrants will be chosen at random to receive a pair of tickets to a Boston major league baseball home game ("Prizes"). One Entrant will be chosen at random to receive the Grand Prize: 4 Loge Box Tickets to a Boston major league baseball home game on August 19th, 2017, a radio booth tour, and a batting practice viewing. ("Grand Prize").

All entries must be complete to be eligible. Entries must consist of information necessary to recycle an old refrigerator or freezer including name, address, city, state, zip code, date of pick up and email address. Entries received during the Promotion Period and which are otherwise fully compliant with these Official Rules and the instructions posted on the Website are valid entries ("Valid Entries") for the prize offered during that Promotion Period. Limit one (1) entry per household during the Promotion Period. In the event of a dispute as to who submitted an entry, the name of the authorized account holder associated with the Eversource residential electric account at the address on the entry form will be deemed to be the Entrant and such Entrant must comply with these Official Rules. Potential winners are subject to verification by use of proper

identification and/or may be required to show proof that they are the authorized account holder. Entries that are late, lost, stolen, undelivered, contain false information, damaged, misdirected, garbled or incomplete, altered or otherwise irregular, generated by script, macro or other automated means, that have been submitted through illicit means or by any means which subvert the entry process or that do not conform with or satisfy any or all of the conditions set out in the Official Rules will be void. Prizes: 10 Entrants will receive a pair of tickets to a Baseball Experience home game.

Grand Prize: 1 Entrant will receive four Loge Box Tickets to a Baseball Experience home game on Saturday August, 19th 2017 at 7:10pm EDT. Also includes a Radio Booth Tour, and a Batting Practice Viewing.

Total ARV of Grand Prize: \$560.

Selection of Winners/Winner Notification/Odds of Winning: All Entrants who call or go online during the Promotion Period to schedule a refrigerator or freezer pickup and have the unit recycled on or before July 15, 2017 will be identified as eligible Entrants. These Entrants will be identified using program tracking tools supplied by the Sponsor's refrigerator recycling contractor, ARCA, Inc. Ten Entrants will be chosen as a potential winner for the Prizes, one Entrant will be chosen as a potential winner for the Grand Prize. Potential winners may be contacted by phone or email and may be required to provide their full name, address, city, state, zip code, date of birth and phone number (including area code) and to complete any additional documents requested by Eversource. Potential winners will have three (3) business days from notification to provide required information or the prize may be forfeited and awarded to an alternate winner from among all eligible remaining entries.
